On arrival exhibitors report to Gate 2 (Main Gate) at the Fair grounds to await entry. Please park to the side so you do not block the entry. We will begin admitting cars by **5 a.m.** or before if possible.

**Please be patient....** we are doing our best to get you in and out as quickly as possible.

**Security will be there to direct you to parking area**

We ask that you have your booth in place by 8am. Due to very limited space on the square, unloading should be accomplished **within 15 minutes and vehicles removed to parking area by race track.** Bring enough people with you to help accomplish this.

**NO LARGE TRUCKS OR TRAILERS WILL BE PERMITTED TO ENTER**

**TRAILERS SHOULD BE 14ft OR SHORTER**

Our space is very tight and we do not have room for navigation of larger vehicles.

**THIS IS NOT A RESALE SHOW --- CRAFTS ONLY PLEASE!!!**

Only arts & crafts that are HANDMADE, HAND DECORATED OR PERSONALLY DESIGNED by the exhibitor will be allowed.

No food of any kind can be sold from booths. Absolutely no pets allowed. No use of the name or logo of The Neshoba County Fair or Mississippi's Giant Houseparty.

Show closes and all sales will stop by 5 p.m. Exhibitors must vacate the square at this time.

**ALL** exhibitors will be required to pay a 7% sales tax on items sold during the show. Tax forms will be provided and **MUST** be turned into **Fair office (porch area)** as you leave the show.

**ELIGIBILITY**

**ALL EXHIBITORS** must send slides or photo samples of their work for the Screening Committee whether they have exhibited before or not.

All requests to exhibit must contain a completed Application Form, a check for the registration fee, and a self-addressed stamped envelope for reply. Spaces are limited; deadline for receiving entries is May 1, 2018.

**RULES AND FEES**

1. Original arts and crafts ONLY to exhibit and sell at the Neshoba County Fair Arts & Crafts Show, Saturday, July 28, 2018. Only arts and crafts that are HANDMADE, HAND DECORATED, OR PERSONALLY DESIGNED by the Exhibitor will be shown. This is not a resale show. RETAIL WILL NOT BE ALLOWED.

2. The Arts and Crafts Committee reserves the right to restrict the number of exhibitors in any category.

3. A fee of \$125 reserves a space 10 feet wide by 12 feet deep. Exhibitors must leave at least 10 feet between their stand and cabin porches. Exhibitors will be furnished 2 arm band for admission and one parking card. The arm bands must be worn at all times and the parking card must be exhibited on the dash of the car.

4. Electrical service is very limited and cannot be guaranteed.

5. All checks should be made payable to the Neshoba County Fair Association. **THERE WILL BE NO REFUND FOR CANCELLATION.** You will be informed by letter of acceptance. If NOT accepted, your check will be returned. Unfortunately, we only have so much space and cannot guarantee everyone will be accepted.

6. On arrival the exhibits are to report to Gate 2 (Main State) at the Neshoba County Fair to await entry. Exhibitors cannot enter the fairgrounds before 5:00 a.m. This is an outdoor show, and no contingency has been

made for rain. It is recommended that exhibitors use tent or bring plastic to cover displays in case of rain. Exhibitors are responsible for any equipment necessary to display their work, which must be in place by 8:00 a.m. Due to limited space on The Square, **unloading should be accomplished within 15 minutes and vehicles removed to parking area** so that other exhibitors can get in to unload. You will be directed to parking areas.

7. **Booths are numbered and assigned. No exhibitor will be allowed more than 2 spaces.**

8. DIRECTIONS TO SPACE WILL BE GIVEN AS VEHICLE ENTERS SET-UP AREA.

9. ABSOLUTELY NO FOOD OF ANY KIND-CANNED OR FRESH- CAN BE SOLD FROM AN EXHIBITOR'S BOOTH.

**10.ABSOLUTELY NO PETS ALLOWED!**

11.No use of the name or logo of **The Neshoba County Fair® or Mississippi's Giant Houseparty®** is permitted.

12.Show closes and all sales will stop at 5:00 p.m. Exhibitors must vacate The Square at this time.

13.All exhibitors will be required to pay a 7% sales tax on items sold during the show. Tax forms will be provided and must be turned into Fair Office as you leave the show. **THIS MEANS EVERYONE!**
