## Exhibitor Application

### Eligibility

- Exhibitors must submit photo samples of their work for the Selection Committee by email to: [neshobacountyartscrafts@gmail.com](mailto:neshobacountyartscrafts@gmail.com)
- All requests to exhibit must contain a completed application form, a check for the registration fee, and a self-addressed stamped envelope for reply. Spaces are limited; the deadline for receiving entries is June 6, 2025.

### Rules

- Only arts and crafts that are hand-made, hand-decorated, or personally designed by the exhibitor will be allowed to be sold in the market. **This is not a retail show. Retail will not be allowed.**
- No food of any kind, canned or fresh, can be sold from an exhibitor's booth.
- No use of the name or logo of The Neshoba County Fair® or Mississippi's Giant Houseparty® permitted.
- The Arts and Crafts Committee reserves the right to restrict the number of exhibitors in any category.
- Each exhibitor will be furnished with 2 armbands per spot for admission and one parking pass per spot. This means people purchasing 2 spots, will have a total of 4 armbands and two parking passes. The armbands must always be worn, and the parking card must be displayed on the car's dash.
- Electrical service **IS NOT PROVIDED.**
- You will be informed by letter of acceptance if NOT accepted, your check will be returned. Unfortunately, we only have so much space and cannot guarantee everyone will be accepted.
- Exhibitors cannot enter the fairgrounds before their assigned time. You will receive this time in the mail along with other detailed information.

### Rules (cont.):

- Please arrive 30 minutes before assigned time and wait for a call to come to Gate 2 (Main Gate) for entry into the fairgrounds.
- This is an outdoor event, and no contingency has been made for rain.
- It is mandatory that exhibitors use tents and bring plastic to cover displays in case of rain.
- Exhibitors are responsible for any equipment necessary to display their work, which must be in place by 8:00 a.m.
- Due to limited space on Founders Square, unloading should be accomplished within 15 minutes, and the vehicles should be removed to the parking area so that other exhibitors can unload. You will be directed to parking areas.
- Booths are numbered and assigned. All exhibitors will be allowed up to 2 spaces.
- Directions to space will be given as the vehicle enters the set-up area.
- Absolutely no pets allowed!
- The show closes, and all sales will stop at 3:30 p.m. Exhibitors must vacate Founders Square. No vehicles will be allowed onto the square until 3:30.

### Fees and Financial Information

- A fee of \$150, made payable to the NCFA, reserves a space 10 feet wide by 12 feet deep. Exhibitors must leave at least 10 feet between their stand and cabin porches.
- There will not be a refund for cancellation.
- All exhibitors must pay a 7% sales tax on items sold during the show. Tax forms will be provided and must be turned in to the Fair Office as you leave the show.
- The NCF must file the sales tax on Monday, July 28, 2025. If your tax is not paid before you leave, a fee will be charged by the State Tax Office. The NCFA will not be responsible for paying this fee!

I understand that I will not receive a refund if I am selected and unable to participate. I also know I have 15 minutes to unload in the morning and must be ready to go by 8:00 a.m.; at 3:30 p.m., I will have 15 minutes to load back up in the afternoon. I agree that I will not enter the fairgrounds before my assigned time for setup. Furthermore, I am aware that I am only allowed a 10 ft. by 12 ft. space (unless paying for two spots) and must leave 10 ft. between my setup and the front porch of the cabins near me. Lastly, I understand my entry is subject to committee approval and submitting all the required items in the checklist above on time.
